

**DICE TOWER EAST 2023
ALLPLAY TABLE GIVEAWAY
OFFICIAL RULES**

NO PURCHASE, ATTENDANCE AT DICE TOWER EAST 2023, REVIEW OR ENDORSEMENT, SUBSCRIPTION, OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THE SWEEPSTAKES OR WIN. A PURCHASE, ATTENDANCE AT DICE TOWER EAST 2023, REVIEW OR ENDORSEMENT, SUBSCRIPTION, OR PAYMENT DOES NOT AND WILL NOT INCREASE YOUR CHANCES OF WINNING.

VOID OUTSIDE THE UNITED STATES, IN PUERTO RICO, AND WHERE PROHIBITED BY LAW.

DETAILS OF THE PRIZES AND HOW TO ENTER THE SWEEPSTAKES ARE CONTAINED IN THESE OFFICIAL RULES.

Eligibility. The “DICE TOWER EAST 2023 ALLPLAY TABLE GIVEAWAY” (the "Sweepstakes") is open to legal residents of the United States during the Entry Period who are at least 18 years of age at the time of entry. The following persons are not eligible for the Sweepstakes: Employees and affiliates of The Dice Tower (“TDT”), including content creators; employees and affiliates of any Sweepstakes, including but not limited to Dice Tower East (“DTE”) and Allplay; any company or any individual involved with the design, production, execution, or distribution of the Sweepstakes; immediate family members (meaning spouses, parents, siblings, and children living in the same household) of any of employee, sponsor, or affiliate set forth above; and residents of Rhode Island. The term “employees” includes officers and directors.

Proof of legal United States residency, age, and eligibility verification may be required.

Sweepstakes Period. The Sweepstakes begins at 12:01 a.m. EDT on **July 4, 2023** and officially ends at 11:59 p.m. EDT on **July 8, 2023** ("Entry Period").

How to Enter the Sweepstakes.

Entry via form, which can be accessed by visiting <https://dicetower.com/contests>. Entries may be collected by visiting the website directly, via a shared link, or via a QR code before the end of the Entry Period.

All entrants (“Entrants”) are subject to verification of eligibility before a prize can be awarded. No entries will be acknowledged or returned.

Limitations: Limit one (1) entry per person during the Entry Period. Limit one (1) prize/winner per person for the Entry Period. Entries will not carry forward to a drawing for any future Entry Period.

Disqualification. Each Entrant represents and warrants that his/her entry conforms to these Official Rules and understands that Sponsor, in its sole discretion, may disqualify the entry for any reason, including if it determines, in its sole discretion, that the entry fails to conform to these Official Rules in any way. Sponsor in no way promotes illegal acts, and any and all entries that include or promote illegal acts will be disqualified. Entries generated by script, macro, or other automated means or by any means which subvert the entry process are void. Any attempt by any Entrant to obtain more than the allowed number of entries per person by using multiple/different email addresses, identities, registrations, logins, and/or any other methods will void any entry by that Entrant and could result in disqualification from this Sweepstakes and/or disqualification from all future sweepstakes by the Sponsor and at Sponsor's sole discretion.

Prize Drawing and Odds of Winning: There will be one Winner ("Winner") of the Sweepstakes for the Entry Period. The decisions of Sponsor, including the selection of Winner, are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of Entries during the Entry Period. Winner will be determined by random drawing on **July 9, 2023**.

Prizes. One Grand Prize Winner will be drawn. Winner will receive one Jasper regular game table, which accommodates six people and features a 3'x5' play area, premium neoprene play surface, four-piece topper, and four cup holders from Allplay. The total value of the Grand Prize shall be approximately \$1,256 USD.

Winner shall be solely and fully responsible for any and all applicable federal, state, city, and/or local taxes (including income and withholding taxes) on the value of the Prize. GP Winner will be issued an IRS 1099-MISC tax form for the retail value of the Prize, as required by federal law.

The Prize is awarded "As Is". Neither Sponsor nor any of its affiliates make or offer any warranties or guarantees, either express or implied (including but not limited to quality, merchantability, and/or fitness for a particular purpose) in connection with this Sweepstakes or any Prizes. Prize details and availability are subject to change, in which case a prize of equal value may be substituted at Sponsor's sole discretion. Winner Notification and Verification: The Winner will be announced in the Antigua Conference Room on July 9, 2023 at 10:30 AM EDT during the Dice Tower East convention, which will be held at Caribe Royale Orlando located at 8101 World Center Drive, Orlando, FL 32821. Attendance is voluntary and is not required for Winner to claim their prize.

Winner will be notified by email from the Sponsor on **July 9, 2023**. Awarding of a prize is subject to verification of a potential Winner's eligibility and full compliance with these Official Rules, in the sole discretion of the Sponsor. To claim a Prize, Sponsor may require Winner to complete, sign, and return Affidavit of Eligibility/Liability Release/Publicity Release forms, and other applicable documents, if necessary, which may require a social security number and the Winner's complete shipping address, such documents to be emailed to Sponsor or sent via first-class mail postmarked within seven (7) days of the date on the notification. At Sponsor's discretion, Winner may be required to produce a photo ID to claim their Prize.

If a potential Winner cannot be contacted, is disqualified, fails to timely execute and return any required forms, or if the Prize notification is returned as undeliverable, an alternate Winner will be selected by random drawing from all remaining eligible entries. If by reason of printing or other error, more Prizes are claimed than the number of Prizes set forth in these Official Rules, a random drawing will be held to award the advertised number of Prizes in the relevant category. Under no circumstances will more than the advertised number of Prizes be awarded.

Prizes shall be shipped to Winners at Sponsor's discretion (such fulfillment is expected to take approximately thirty (30) days but may vary depending on the circumstances).

Agreement to Official Rules. Participation in the Sweepstakes constitutes Entrant's full and unconditional agreement to and acceptance of these Official Rules and Sponsor's Privacy Policy at www.dicetower.com and to be contacted by telephone and/or email. Sponsor reserves any and all rights to solely interpret and administer these Official Rules which shall be final and each Entrant agrees to abide by all Sponsor decisions regarding this Sweepstakes. In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any Sweepstakes-related materials, the terms and conditions of these Official Rules shall prevail, govern and control.

LIMITATION OF LIABILITY AND RELEASE OF CLAIMS: By participating in this Sweepstakes, Entrants release and agree to hold harmless TDT and DTE, the administrator, Sierra Orlando Properties, LTD dba Caribe Royale Orlando, and 902A, LLC dba Allplay (the "Released Parties") from and against any claim or cause of action and any and all liability with respect to or in any way arising from, this Sweepstakes or acceptance, possession, receipt, or use/misuse of the Prize. **As a condition to entering the Sweepstakes, each Entrant agrees that: under no circumstances will the Entrants or Winner be permitted to obtain any award for, and the Entrants and Winner hereby waive all rights to any claim(s), punitive, incidental, or consequential damages, or any other damages whatsoever, including attorneys' fees. Disputes. Entrants and Winner agree that any and all disputes and causes of action arising out of or connected with this Sweepstakes and the Prizes awarded shall be resolved solely by Sponsor, shall be final and binding, and without resort to any form of class action.

The Sweepstakes is governed by the laws of the United States and the State of Florida, excluding conflicts of laws principles. All federal, state and local laws and regulations apply. Entrants in the Sweepstakes hereby consent to the exclusive jurisdiction and venue of Florida courts (state and federal) in Miami-Dade County for any causes or controversies arising out of the Sweepstakes. Winner waives any and all objections to jurisdiction and venue in these courts.

General Conditions. Sponsor reserves the right to cancel or modify the Sweepstakes for any reason, including but not limited to fraud or any other factor impairing the integrity of the Sweepstakes or Sponsor's ability to award Prize as determined by Sponsor in its sole discretion. If, in Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if technical difficulties compromise the integrity of the Sweepstakes, Sponsor reserves the right in its sole discretion to void any entries at issue (including disqualifying any individual who tampers or otherwise interferes with the entry process or the integrity of the Sweepstakes), and to cancel, terminate, modify, or suspend the Sweepstakes, in whole or in part, at any time without notice.
